ITF Membership:

Members of the ITF register as one of the following:

Association Member

- Any industry or professional association registered in Alberta whose membership represents account holders in the WCB-Alberta.

Corporate Member

- Any legally registered company in Alberta that is required by the Alberta WCB Act to be an account holder in the WCB.

Prospective members must complete an application form and provide the necessary contact information to the Association Administrator. Upon approval by the Executive, the applicant will be invoiced for their membership dues. A new member will begin to receive information on meetings and current issues upon receipt of payment.

Association members may designate two (2) voting members to attend meetings on behalf of their organization. Corporate members may designate one (1) voting member.

Membership includes access to resources on the Members Only website and the online member discussion forum.

Membership fees for the 2020/2021 ITF fiscal year are \$550.00 for a Corporate membership and \$1,100.00 for an Association membership.

General Information:

The ITF Association is registered under the Societies Act in Alberta. An Executive Committee is elected yearly by the members to manage the business affairs of the Association. Day to day administration is handled by the Association Administrator.

The ITF Association holds full day regular meetings four (4) times per year, with two (2) meetings in Edmonton and two (2) meetings in Calgary.

These quarterly meetings bring together members to review and make recommendations on WCB initiatives, proposed policy and legislative changes, proposals to enhance customer service, and to address other emergent issues. A significant portion of each agenda is devoted to direct communication with the WCB Executive and Board of Directors. Senior officials from the WCB Appeals Commission, Ministry of Labour, and Workplace Health & Safety also attend as appropriate.

A strong network of ITF sub-committees, led by experienced and knowledgeable member volunteers, collaboratively work to address current issues on an on-going basis. Input on key issues, such as changes to policy or legislation, is solicited from all members. ITF recommendations and submissions are reviewed by the membership prior to submission or presentation.
